OPERATIONAL GUIDELINE FOR IMPLEMENTATION OF THE PROGRAMME PERENNIAL FODDER CULTIVATION IN FARMERS FIELD AND PASTURE LAND DURING THE YEAR 2021-22

UNDER STATE SECTOR SCHEME

"TRAINING & DEMONSTRATION IN FODDER CULTIVATION AND PASTURE DEVELOPMENT AND STRENGTHENING OF DEPARTMENTAL FODDER FARMS OF ODISHA".

Perennial Fodder Cultivation Programme:-

Under this programme individual livestock farmers, beneficiaries under MGNREGS and user groups of pasture land will be provided with Perennial fodder seed to grow perennial fodder crop in their own land and pasture lands. Perennial fodder Sorghum crop seed like COFS-29 & COFS-31 are to be supplied during Kharif 2021-22 for perennial fodder cultivation over 2500Ac. The seed will be procured from Govt. of India as well as Govt. of Odisha approved seed suppliers. The seed procured will be supplied to the farmers and user group on free of cost through extension chain i.e. CDVOs

Use of Key criteria for the perennial fodder cultivation programme and the justification.

Towards Sustainable development goal	Small holder farmers and user group of pasture land avail green fodder by cultivating fodder in a patch of irrigated land. Once the experience if gained they extend the area as per their capacity.
Towards Increasing farmers income and enhancing income activities	Both Kharif and Rabi are two seasons when farmers become bound to stall feed their livestock as the field are occupied with grain crops or cash crops. Farmers have to buy green fodder or dry fodder that is expensive. By cultivating perennial fodder they are able to mitigate the green fodder scarcity to a large extent.
Towards Empowering women	Perennial fodder are easy to harvest for which women farmers who go to field or CPR to avail green fodder are facilitated with ease of harvest.
• Towards Skill development	Perennial fodder cultivation require a good skill for adopting different agronomic practice.
Towards Enhancing participation of other vulnerable population	Vulnerable population not having enough land can take up fodder cultivation in a small area measuring 25 cents.

Programme details of perennial fodder cultivation programme during 2021-22

It is proposed to take up the perennial fodder cultivation programme in the entire state covering 30 districts. Accordingly during Kharif 2021-22, 60 Qtl of perennial fodder seed is proposed to be supplied to the farmers and user group to cultivate perennial fodder crop over 2500 acres.

Total Budget proposed for Perennial fodder cultivation programme in the entire state over 2500 Acres perennial fodder crop @2.4Kg per Ac= 60 Qtl of seed@ Rs 470 per Kg Total to Rs.28,20,000 (Rupees Twenty Eight Lakhs Twenty Thousand) only.

Operational Guideline for the Programme

- Fodder seed like COFS-29 & COFS -31 will be supplied to the selected beneficiaries on free of cost for perennial fodder cultivation for at least 0.10Hactere to maximum 1.00 Ha with maximum limit of 6 kg seed as the seed rate for 1 Acre of crop cultivation is 2.40 kg.
- During selection of beneficiary MPCS /Fodder Cooperative group /SHG/NMPS/CAE/DEDS/MKUY members as well as SC/ST and women farmers should be given preference.
- The beneficiary selected should have irrigated land to raise perennial crop for obtaining green fodder round the year.
- The requisite quantity of fodder seed COFS- 29 & COFS- 31 will be supplied to the user community @ 2.40Kg. seed per acre on **free of cost** for perennial fodder cultivation in their own land /Govt waste land(Gochar) etc in different schemes.
- The beneficiary selected and the area under perennial fodder crop raised by user community should be communicated to the Directorate in the prescribed proforma enclosed herewith in ANNEXURE – I.
- The Geo-Tagged photographs along with success stories to be submitted to the Directorate (both soft & hard copy). The achievement of this programme to be incorporated in the Monthly Progress Report (MPR).
