Scheme : Establishment of Mini Poultry Feed Mill during the year 2021-22

AIM:

This scheme aims to support establishment of 100 nos. of poultry feed mill during 2021-22.

SCHEME OBJECTIVE :

- To establish portable feed mixing units of capacity 50 kg. per hour at individual/ group level.
- To provide income generating opportunity in rural areas.

SCHEME OUTLAY & SUBSIDY :

- The unit cost of one portable feed mill unit is Rs.2.80 lakh.
- Subsidy amount for individual beneficiaries @ 40% amounts to Rs.1,12,000/-.
- Subsidy amount for WSHG @ 50% amounts to Rs.1,40,000/-.

ELIGIBILITY :

- The willing Individual beneficiaries / WSHGs will be eligible to avail support.
- The Individual beneficiaries / WSHGs those have availed subsidy previously in similar scheme or in verge of getting subsidy should not be included.

SOURCE OF FUNDS & CONTRIBUTION :

SUPPORT FROM THE DEPARTMENT :

- Training of WSHG/ Individual beneficiary will be organized at Block Head Quarter level or any other convenient place after final approval of the list.
- The feed plant will be managed by the members of WSHG / Individual beneficiaries.
- Each WSHG / Individual beneficiary will be trained on recommended management and production of feed.

DOCUMENTS REQUIRED :

- 1. Identification Proof (Aadhaar Card).
- 2. Land Document / Lease Deed (Photocopy).
- 3. Bank A/C No. with IFS Code for DBT (Photocopy).
- 4. Self-Declaration with reference of WSHG / Individual beneficiary.

PROCESS FOR PROVIDING SUBSIDY :

- 1. Submission of application as per EOI floated by DSWO for WSHG only.
- 2. BVO checks documents, upload photo and submit verification report.
- 3. Issue of Go-Ahead Letters by CDVO.
- 4. Physical verification of the completion of construction of building by Block Inspection Team (BIT).
- 5. Release of First Installment through DBT.
- 6. Physical verification of after installation of plant & machinery.
- 7. Release of Second / Final Installment through DBT
