# 'Livelihood Support to Farmers through Backyard Poultry to Individual Members of Women Self Help Group under

'State Plan" Scheme during the year 2020-21

Directorate of Animal Husbandry & Veterinary Services, Odisha, Cuttack Modalities for implementation of the scheme 'Livelihood Support to Farmers through Backyard Poultry to Individual Members of Women Self Help Group' during the year 2020-21

#### Background:

Raising improved local poultry breeds in backyard is an important source of livelihood for the rural people of Odisha. Poultry keeping in backyard condition gives high return as the investment in form of raw material and maintenance are low. The birds can be easily reared and handled by the farmers in village condition. Improved coloured birds under low input technology like Vanaraja, Chhabro, Kuroiler & Rainbow Rooster, Kalinga Brown, RIR and Other approved breed of Gol etc have its own merit because of its meat quality, high body weight, disease resistance and majestic look.

The care of a small backyard flock can help fill the family food requirements for eggs and meat. It can also be a source of additional income. A valuable by-product is the chicken manure which is a very excellent organic fertilizer for farm and home gardens. It has been found that the dual purpose low input technology birds are reared under scavenging condition. They are dual purpose multi-colour birds with higher genetic potential resembles deshi birds in their physical characteristics. These birds have triple advantage of the characteristics of the indigenous birds in terms of hardiness & colour, high egg laying capacity (upto 130-150 eggs per year), and high weight gain (2.5 kg to 3 Kg at 3 months. The eggs are brown coloured and fetches good price compared to white shelled eggs. The hens are kept for egg production and males are sold for meat purpose. Moreover, after the laying period, the spent hens can also be sold by the farmers with reasonable price which will add to their family income.

Under the programme, each household will be provided with 50 nos. of unsexed 4 weeks old LIT birds (Low Input Technology) for scaling up of backyard poultry production which will enhance the income of farmers in rural area and also provide nutritional security at household level.

#### Aim:

The aim of the scheme is to support 9600 farmers for backyard rearing of poultry birds with a capacity of 50 birds per unit during 2020-21.

#### Objective:

#### The project intends -

- To strengthen local poultry Production Systems for enhancing livelihoods of individual members of Women SHGs excluding the selected Women SHG for Semi Commercial Layer Farming in Deep Litter System.
- To build the capacity of the individual members of Women SHGs for undertaking backyard poultry production as a profitable enterprise.
- To provide supplementary source of income to rural women.
- To meet the protein hunger at grass root level.

To meet these objectives, there is need to increase both the mass production and production by masses, but with a focused approach of building capacity of the poorest of the poor farmer to become an entrepreneur who can be a part of the mainstream business environment to contribute and for economic development.

#### Target Beneficiaries:

Under the scheme, 9,600 individual members of Women SHG excluding the selected Women SHG members for Semi Commercial Layer Farming in Deep Litter System will be supported for rearing 50 unsexed Low Input Technology (LIT) poultry birds each under scavenging system.

#### Selection of Farmers:

- Individual members of Women SHG excluding the selected Women SHG members for Semi Commercial Layer Farming in Deep Litter System will be selected under the programme.
- ii. Should be a permanent resident of the Village/ Panchayat.
- iii. A Block Level Committee to be formed with BVO/ AVAS and Mission Shakti Coordinator and concerned L.I. They will identify the potential Women SHG and individual SHG member.
- iv. The Women SHG beneficiaries will be selected and the list of the farmers with signature of the concerned paravets, and the PRI Members will be submitted to the concerned Block Veterinary Officer (BVO).
- v. The BVO after countersigning the beneficiary list will submit the same to the concerned CDVOs for approval through the concerned SDVOs.

- vi. The Block wise final list of the beneficiaries will be submitted by the CDVOs to Director, AH&VS, Odisha, Cuttack for uploading the list in the Departmental Website.
- vii. Training will be organized at Block Headquarter level or any other convenient place after final approval of beneficiary list. 50 farmers in a batch will receive training on backyard poultry on recommended management practices on feeding and watering, brooding and rearing young chicks, record keeping, etc. out of the existing training funds if any with the districts or DLRDS funds.
- viii. The Pranimitras engaged under OLM, Gomitras, BAIF workers and Cluster Coordinators will be oriented at Block Headquarter by AVAS/ BVO regarding recommended management practices in backyard poultry. They will be roped in to guide the farmers in field for managing backyard poultry units.
- ix. Small-scale poultry units in the backyard will be managed by households using family labour.
- x. A Night Shelter will be constructed before receiving chicks by the beneficiaries using local materials for minimum expense. An assistance of Rs.500/- will be provided to each farmer for construction of a night shelter.
- xi. The farmers will arrange feed for chicks during the early stage as per the availability of local ingredients. The birds will be reared in free range system with little hand-feeding especially kitchen-wastes.
- xii. 50 numbers of four weeks old unsexed Low Input Technology(LIT) birds will be distributed to each farmer in two phases (25+25) with a gap of 3 months.

#### Procurement of Chicks:

CDVOs shall assist in procurement and supply of chicks.

#### Monitoring:

Regular monitoring will be done at department level and district administration level. The CDVO of the district will co-ordinate with department field functionaries for proper implementation as well as co-ordination with district administration. Directorate of AH&VS will review the progress every fortnight.

Timely disease prevention measures through routine vaccination & other health care programmes will be taken up to minimise occurrence of diseases & thus preventing mortality of birds.
