Scheme: Support to Farmers/ Agri Entrepreneurs for setting up of Commercial Agri Enterprises (CAEs) under Mukhyamantri Krushi Udyog Yojana (MKUY) implemented by APICOL during the year 2020-21

BACKGROUND :

'Mukhyamantri Krushi Udyog Yojana' is a State Funded scheme for establishment of more number of Commercially Viable Agri Enterprises (CAEs) in the State in a **simple, online, transparent & timebound** manner. An agri entrepreneur has to apply online through an user friendly webportal www.apicol.nic.in. MKUY has been launched on 01.06.2018 for ensuring efficient service delivery for agri entrepreneurs by way of ease of doing agribusiness under State Agriculture Policy. APICOL is designated as the State Nodal Agency and Line Departments are the implementing MKUY in the State.

SCHEME OBJECTIVE :

- To promote agro-based/ food processing industries, Commercial agriculture/ Horticulture/ Animal Husbandry & Fisheries, in broad terms to enhance private investment in Agriculture and allied sectors.
- To generate employment, provide livelihoods and sustainable income for farmers/ agri entrepreneurs.

FUNDING PATTERN :

- **Entrepreneur Contribution-** As per requirement.
- **Back Ended Capital Investment Subsidy-** 40% for general male and 50% for all Women/ SC/ ST/ Graduates in Agriculture & allied sectors limited to Rs.50.00 lakh.
- **Effective Bank Loan-** Minimum of 10% of the outlay for Projects costing more than Rs.10.00 lakhs. Projects costing less than Rs.10.00 lakh may be done with own finance.

ELIGIBILITY :

- The eligible beneficiary include an individual, partnership enterprise, body of individuals, registered NGOs, SHGs and private limited companies.

- **Group of Individuals like registered FPOs, FPCs, NGOs, SHGs, PACS, LAMPS, Private Limited Companies etc.** The applicant should be a permanent resident of Odisha.
- There should be minimum net annual income of Rs.2.00 lakh from a CAE.
- **Land-** No subsidy will be paid on cost of land. The land on which the CAE is proposed to be set up should be:
 - a) In the Name of Entrepreneur/ Group/ Company/ Partners, or
 - b) Leased out in favour of Entrepreneur/ Group/ Company/ Partners for a period of more than 15 years in the office of the concerned Sub-Registrar.
 - c) Leasing of land is not required in case of woman entrepreneur if the land stands in the name of her husband.

FINANCIAL INSTITUTIONS ELLIGIBLE FOR FINANCE :

- Scheduled Commercial Banks
- Regional Rural Banks
- State Cooperative Banks
- State Cooperative Banks, Agriculture and Rural Development Banks, Urban Cooperative Banks
- Such other institutions, which are eligible for refinance from NABARD.

MODE OF APPLICATION & DOCUMENTS REQUIRED :

The agri entrepreneur is required to submit online application in the web portal www.apicol.nic.in with a Farmer ID and upload supporting documents viz: Aadhaar Card, Voter ID, Land Documents etc. and DPR in the Beneficiary Master Section.

The project is to be completed within a period of 2 years from issue of Go Ahead after approval by the DLC under the Chairmanship of Collector & DM of the District.

SUPPORT FROM THE DEPARTMENTs & APICOL :

- Training of farmers will be organized at Regional/ District/ Block level.
- Each potential entrepreneur will be trained on establishment, maintenance and successful running of the project, recommended management practices and record keeping, etc.

- The concerned Block Level Officers of Line Departments (BAO/ BVO/ AFO/ AHO) will guide the farmers in field for successful establishment and management the unit.
- CDVO will help the agri entrepreneurs in obtaining Go Ahead and processing of documents for release of subsidy from APICOL.
- District Managers appointed by the Department of Agriculture & FE for APICOL will coordinate with the agri entrepreneurs and District Level Officers and DLC members/ BLOs at field level.
