Scheme: Support to Farmers for "Supply of Motorized Chaff Cutter" under National Livestock Mission during the year 2020-21

AIM:

This aim of the scheme is to support 60 farmers for installation of motorized chaff cutter (1 HP)with a capacity of chaffing green and dry fodder up to 5 MT on daily basis provisioning a subsidy of Rs.6,000/- per unit during 2020-21.

SCHEME OBJECTIVE:

- To minimize the wastage of green and dry fodder and increase the digestibility.
- To build the capacity and sensitize the farming community for chaffing of green and dry fodder and feeding to livestock.
- Increasing farmers' income.

SCHEME OUTLAY & SUBSIDY:

- Unit cost of one Motorized Chaff Cutter (1 HP is appx. Rs.25,000/-).
- Central Share amounts to Rs.6,000/-per unit as subsidy.
- Beneficiary Share amounts to Rs.19, 000.00.per unit.

ELIGIBILITY:

- All categories of farmers having at least 5 to 20 large dairy animals and cultivating fodder in their own land or in groups will be eligible to avail support.
- Preference should be given to SC/ ST/ Women farmers and entrepreneurs enlisted under schemes namely DEDS/ CAE/ MKUY.

SOURCE OF FUNDS & CONTRIBUTION:

Centrally Sponsored Plan Scheme.

SUPPORT FROM THE DEPARTMENT:

- Training on fodder production and use of Chaff Cutter will be organized at Block Head
 Quarter level or any other convenient place after final approval of the list.
- The Motorized Chaff Cutter unit will be managed by the farmers.
- Each farmer will be trained on recommended practices of chaffing usage of chaff cutter, etc.
- The concerned Livestock Inspectors, Fodder staff of the district will have to guide the farmers in usage of Chaff Cutter.
- The capacity building of Lls, Fodder staff will be taken up by the DAH&VS, Odisha

DOCUMENTS REQUIRED:

- Identification Proof (Aadhaar Card).
- Bank A/C No. with IFS Code for DBT (Photocopy).

PROCESS FOR PROVIDING SUBSIDY:

- Online application in the ServicePlus Portal.
- BVO checks documents, visits the site for genuineness of installation and submit verification report to CDVO.
- Approval by district CDVO and issue of Go-ahead.
- Deposit of beneficiary share of Rs.19,000/-.
- Installation &demonstration of Motorized Chaff Cutter at farmers' doorstep.

TRACKING STATUS OF APPLICATION & COMPLAINTS:

- Status can be tracked online in the ServicePlus Portal.
- SMS alerts to be provided to beneficiaries.
