Job Chart of Sub-Divisional Veterinary Officers (OVS Group-A Senior) in restructured OVS Cadre

- 1. He/ She will function as head of the ARD Sector of the Sub-division.
- 2. He/ She will supervise Sub-Divisional Veterinary Hospitals under his jurisdiction.
- 3. He/ She will submit monthly reports and returns of the Sub-division to the Chief District Veterinary Officer.
- 4. He/ She will act as the Drawing and Disbursing Officer for all Plan & Non-Plan schemes implemented in the Sub-Division, where such power is vested with him/her.
- 5. He/ She will supervise and inspect VDS/LACS and other field institutions under his jurisdiction and submit his/her report to CDVO.
- 6. He/ She will approve the tour programme and tour diaries of all field officers working under his/her administrative control.
- 7. He/ She will grant C.L to all Block Veterinary Officers/VAS working under his/her administrative control.
- 8. He/ She will ensure proper implementation of Animal Husbandry and Veterinary service programmes in the Sub-Division. He/ She will ensure that, health and breeding activities and all extension services to the beneficiaries under different schemes are properly implemented in the Sub-Division.
- He/ She will place indents for medicines, equipments, vaccines and other articles for the institutions under his/her control to the Chief District Veterinary Officer.
