GUIDELINE OF STATE SECTOR UMBRELLA SCHEME "MMKY- REVOLVING FUNDS FOR WSHGS INVOLVED IN FISHERIES ACTIVITIES" FOR THE FY 2023-24

1. Introduction

The Fisher women SHGs involved in pisciculture in GP tank /Biofloc, Fish marketing, fish value addition like dry fish making/fish pickle /other byproducts preparation etc. usually face difficulties in procurement of raw materials due to paucity of funds and usually opt to get from private sources. It is essential to support the WSHG through provision of Revolving fund to meet the higher demand of fisheries related activities.

It is essential to support them through provision of Revolving funds of Rs. 10,000 per WSHG. In order to encourage their business, it is proposed to provide fund of Rs. 10,000/- to them to carry out the activity smoothly.

2. Aim & Objective

- i. Promotion of WSHG involved in Fisheries activities.
- ii. To provide financial support to the WSHGs

3. Area of Operation:

The scheme shall be implemented by the District Fisheries Officer for supporting WSHGs. The district-wise annual target shall be communicated by the Director of Fisheries. The target is interchangeable depending on the progress made by the District Level Officers.

4. Eligibility Criteria:

- i. Must be a WSHG involved in pisciculture, fish value addition & fish marketing, biofloc farming, ornamental fish farming, shrimp farming etc.
- ii. Must have a bank account in thename of WSHG in the State of Odisha.
- iii. WSHGs availing benefit under-Input Assistance for Pisciculture in GP tanks", shall not again be considered for revolving fund assistance under this program.

5. Pattern of Assistance

Revolving fund amounting to Rs. 10,000/- per WSHG (One time assistance)

6. Implementation Procedure

- The scheme would be widely published by the Director of Fisheries/ District Fisheries Officer.
- ii. The WSHGs shall submit application (Annexure-I) to the District Fisheries Officers through the AFOs/ Field functionaries of the Fisheries Department.
- iii. The verification shall be undertaken by respective AFOs or field functionaries & take help of BPC, Mission shakti & CDPOs concerned for finalization of applications.
- iv. The WSHG should submit the undertaking regarding non-availing of any kind of similar assistance previously for fisheries activities.

- v. After verification, the AFOs/ Field functionaries shall recommend (Annexure-II) for release of revolving fund to the District Fisheries Officers of the concerned district.
- vi. AFOs shall take the geo tagged photographs of the fishery unit managed by the WSHG and copy of their resolution for taking up any fisheries related activities and submit the documents to the DFO for creation of case record at district office.
- vii. The revolving fund of Rs. 10,000/- shall be granted once to the particular eligible WSHGs by the DFOs.
- viii. Upon receipt of the documents, the assistance shall be released by the DFO to the account of the WSHGs through DBT/NEFT/RTGS.
 - ix. District official can enhance the it up to 25% of their allocated target and district officials are free to reallocate block targets as per demand (Lt. 883/FARD dt 21.1.23).
 - x. The Director, Fisheries will review the monthly progress of the Scheme & collect Monthly Progress Report in proper proforma developed at Directorate level.
